Completed applications are to be made in a sealed envelope and posted "for the attention of the Membership Secretary" in the grey post-box inside the clubroom.
- 3. DATA PROTECTION ACT.

Data on members will be held by Tondu Target Shooting Club as the Data Controller. The Club must inform the Police Fire Arms licensing department of all membership applications under home office rules and also supply data to any bodies requiring the data of the Secretary, as the Club's representative under the Act.

4. FAMILY MEMBERS.

Family members need to submit individual membership application forms. A Family Member includes a spouse or partner plus any dependent issue, up to 21 years of age, or 25 years of age, if receiving full time education.

- 5. It is an offence for a person who is prohibited by Section 21 of the Firearms Act 1968 to have a firearm or ammunition in his/her possession at any time. This applies to:
 - 5.1 Any person who has been sentenced to imprisonment, or to youth custody, or detention in any young offenders institution for three months or more.
 - 5.2 A person sentenced to a period of between 3 months and 3 years is prohibited for 5 years from the date of release.
- 6. Any member, probationary or otherwise, who does not possess a valid firearms certificate, are warned that taking, or attempting to take, live ammunition from the club premises, is a criminal offence, and will result in immediate expulsion from the Club and criminal prosecution under the Firearms Acts.

Additional Probationary member requirements:

- 7. As a probationary member, there is a need to attend a club induction course during the probationary period. Courses are held in the clubhouse at 10.30am on the first Saturday of each month.
- 8. A current passport sized photo must be provided with this application.
- 9. Where any probationary member has a Firearm Certificate, this must be seen and the verification certified below.
- 10. All probationers over the age of 18 are required to provide proof of identity with the verification certified below.
